Skills Maintenance (Proficiency Check) Requirements for 2024/25 Season v1

Summary

Introduction

The requirements in this circular detail the minimum national requirements for the SLS 2024/25 season as developed in consultation with the Lifesaving and Education Committees and ratified by the Lifesaving Committee. Additional requirements may be required by your relevant SLS state/territory centre.

The lifesaving committee previously approved a three-year cycle for skills maintenance for both the Surf Rescue Certificate and Bronze Medallion. This season the skills maintenance practical will focus on carries and drags.

Theory Component

Members are required to complete the skills maintenance theory component online, as assessment marking and record keeping is automated and reduces the burden placed upon SLS trainers and assessors. If a member is unable to complete this component online, they should speak with their club training officer.

It is an essential requirement that all current **Bronze Medallion** or **Surf Rescue Certificate** award members complete the following:

watch a video update

- the Sexual Harassment and Misconduct Awareness training module
- online learning branching scenario
- online radio module
- online difficult conversations module
- answer questions related to any of the above content.

It is an essential requirement that all current Award members complete:

- the Sexual Harassment and Misconduct Awareness course

It is an essential requirement that all **Radio Operator Certificate** holders complete the following:

- online radio module
- the Sexual Harassment and Misconduct Awareness training module

It is an essential requirement that all current **Silver Medallion Patrol Captain** award members complete:

- online learning branching scenarios

It is an essential requirement that all current **Silver Medallion Beach Management (SMBM)** award members complete:

- the Surf Risk Rating (SRR) training module

What is a branching scenario? A branching scenario is a more interactive form of learning online. The member will be given three scenarios which they must work through, involving rescue and first aid, where they will need to make decisions and then be presented with the consequences of that decision. They will be given choices at each step; with each response they give determining the next part of the scenario given. They are unpredictable and more engaging and can be completed many times with a different outcome. Best of all they put theory into perspective.

Practical component

The information below outlines the practical requirements of each SLSA award for skills maintenance. Where scenarios should be used to combine components; for example, a scenario combining a tube rescue with CPR. Training resources that support SLSA awards are in the <u>SLSA Members Area</u> Document Library. Members are encouraged to review these prior to commencing the patrolling season.

Gap Analysis (Appendix 1)

Appendix 1 indicates the changes in the various awards over the years to enable the necessary updates to be given to the member in the form of an in-depth proficiency. Members who have not remained proficient for any period may not be required to complete their award again and should be dealt with on a case-by-case basis with their club training officer. The guideline set by the Education Committee is that a period of five or more years would require re-completion of the award, however the experience of the individual member should always be considered.

Aquatic Rescue Pathway Awards

Bronze Medallion (BM) and Surf Rescue Certificate (SRC)

- 1. Run-Swim-Run (timed)
 - SRC—Unaided: 100m Run-100m Swim-100m Run in 5 minutes or less
 - BM—Unaided: 200m Run-200m Swim-200m Run in 8 minutes or less
 - The run distance to be taken from waist deep water, e.g., the run is from a flag, around a marker and to waist deep water. The aquatic components are from waist deep water around two swimming buoys and back to waist deep water
 - Swim leg must be around two swimming buoys

o Reasonable adjustment may be made for surf conditions on the day.

2. Signals

Demonstrate knowledge of signals. The demonstration must include the following:

- Beach to water signals
- Water to beach signals

3. Resuscitation (CPR)

- A primary assessment (DRSAB--) on a live victim including the demonstration of the lateral position
- Primary assessment (DRSABCD), CPR 1 and 2 person (adult or child AND infant) on an approved manikin – to include resuscitation methods using a resuscitation mask or face shield and AED (individually issued face shields are preferred, if using masks special cleaning procedures need to be followed)
- Team CPR scenario including primary assessment (DRSABCD) to include resuscitation methods using a resuscitation mask or face shield and AED.

4. Radio

Participation in a scenario involving equipment. The scenario must include at least three of the following situations and must be conducted for each candidate:

- Pre-operation checks
- Knowledge of local operating channels and uses
- Inter-patrol communications
- Rescue procedures, requests for assistance which include the four P's.

5. Rescue

Demonstrate a minimum of one rescue of a victim. SLSA strongly encourages that this is of an unconscious victim, using a Board Rescue and according to SLSA operating procedures in the current *SLSA Public Safety and Aquatic Rescue* training manual. The rescue must include the following:

- Negotiating the surf zone
- Securing the victim
- Returning to shore with the victim
- Calling for assistance

6. Carries and Drags

Demonstrate a minimum of three carries and drags of a victim. This should include carries and drags for both unconscious and conscious victims, according to SLSA procedures in the current *SLSA Public Safety and Aquatic Rescue* training manual. The carries and drags should include the following:

- Two-person carry (trunk and legs)
- IRB carry with or without handover depending on members qualifications
- Two-handed seat carry (recommended for non-tropical waters) OR
- Two-person drag (recommended for tropical waters)

The carry needs to demonstrate the following:

- Appropriate victim airway management (where applicable)
- Correct techniques including safe lifting and manual handling techniques
- Carrying the victim to a safe location and correct lowering of the victim

Silver Medallion Aquatic Rescue (SMAR)

Proficiency is required in the prerequisites for this award to remain current. The prerequisites are:

• Complete a 400m swim in 8 minutes or less in a swimming pool of no less than 25m length

 Hold and be proficient in the SLSA Bronze Medallion [and hold the Certificate II in Public Safety (Aquatic Rescue)].

Gold Medallion (GM)

- 1. A member must be proficient in each of the following awards:
 - Bronze Medallion
 - Advanced Resuscitation Techniques or Advanced Resuscitation Techniques [AID]
 - First Aid or First Aid [AID]

2. Pool Swim

- The member must complete an 800m swim in under 14 minutes in a swimming pool of no less than 25m
- The pool swim must be completed before any other component of a Gold Medallion skills maintenance.

3. Mission Test (timed)

- The distance will be 400m swim, 800m run, 400m board paddle, and 800m run.
- The time will be less than 25 minutes
 - The run distance to be taken from waist-deep water, e.g., the run is from a flag, around a marker and to waist-deep water. The aquatic components are from waist-deep water around two swimming buoys and back to waist-deep water
- o Aquatic course must be around two swimming buoys.

4. Rescue

- Demonstrate a board rescue according to SLSA operating procedures in the current SLSA Public Safety and Aquatic Rescue training manual. The victim should be 200m out to sea
- Demonstrate a tube rescue according to SLSA operating procedures in the current SLSA Public Safety and Aquatic Rescue training manual. The victim should be 100m out to sea and the member should use swim fins during this rescue.
- 5. Complex Rescue Scenario (may include one of the rescues above)
 - Demonstrate a complex rescue scenario as set by the delegated assessor according to the SLSA operational procedures in the current SLSA Public Safety and Aquatic Rescue training manual
 - The rescue must assess the following events:
 - Negotiating the surf zone
 - Securing the patient/s
 - o Returning to shore without losing the victim/s
 - o Calling for assistance
 - o Performing emergency care as required by the victim/s.

Emergency Care Pathway Awards

SLSA awards involving resuscitation are to be assessed annually. Once proficiency is achieved, resuscitation in other SLSA award skills maintenance is not required to be performed again.

Please note that completion of the SLS skills maintenance for any award in the SLSA emergency care pathway is not sufficient to result in the renewal of the HLTAID unit of competency that aligns with the member's award. For example, the skills maintenance for the SLSA Resuscitation award is not sufficient to result in the renewal of a member's HLTAID009 Provide cardiopulmonary resuscitation or HLTAID015 Provide advanced resuscitation and oxygen therapy units of competency. Members should contact their SLS state/territory centre for advice on renewing their units of competency.

Resuscitation

A primary assessment (DRSAB--) on a live victim including the demonstration of the lateral position

- Primary assessment (DRSABCD), CPR 1 and 2 person (adult or child AND infant) on an approved manikin – to include resuscitation methods using a resuscitation mask or face shield and AED. (Individually issued face shields are preferred, if using masks special cleaning procedures need to be followed)
- Team CPR scenario including primary assessment (DRSABCD) to include resuscitation methods
 using a resuscitation mask or face shield and AED.

Advanced Resuscitation Techniques

<u>Please note</u> that the Advanced Resuscitation Techniques Certificate is no longer available to be made proficient this season. The below requirements are for the Advanced Resuscitation Techniques and Advanced Resuscitation Techniques [AID] awards only.

- 1. Resuscitation (CPR)
 - See Bronze Medallion and SRC Skills Maintenance Resuscitation (CPR) component above for requirements.
 - A member is proficient in this component of the ART Skills Maintenance if they have previously completed the BM and SRC Skills Maintenance.

2. Advanced Resuscitation

Team CPR scenario including primary assessment (DRSABCD) – to include resuscitation methods
using a resuscitation mask or face shield, AED, and oxygen supplement (oxygen cylinder connected
to bag-valve-mask resuscitator on an unconscious victim).

3. Oropharyngeal Airways

- Correct measurement and insertion of an oropharyngeal (OP) airway
- Demonstrate an understanding of when and why an OP airway is introduced into resuscitation.

4. Bag-valve-mask resuscitator

Correct use of bag valve mask resuscitator

The deadline for the completion of the upgrade from Advanced Resuscitation Techniques (ART [AID]) - HLTAID007 to Advanced Resuscitation Techniques (ART) – HLTAID015 has been extended from July 2024 to July 2026 (unless a new training package is released prior to this date and HLTAID015 is superseded).

Beach Management/ Award Member Pathway Awards

Radio Operations (RO)

Participation in a scenario involving equipment. The scenario must include at least three of the following situations and must be conducted for each candidate:

- Pre-operation checks
- Knowledge of local operating channels and uses
- Inter-patrol communications
- Rescue procedures, requests for assistance which include the four P's.

For those who use this award as part of their operation within a SLS communications centre, additional skills maintenance requirements may be included at a local level.

Silver Medallion Beach Management (SMBM)

Participate in a practical on-beach session to implement learning from the Surf Risk Rating (SRR) training module.

Powercraft Pathway Awards

Powercraft award holders may need to demonstrate skills in a 'one off' skills maintenance check or may be deemed as proficient via demonstration of competency during normal operational activities. All members must demonstrate proficiency in the pre-requisite awards associated with these awards as follows:

- IRB Crew
 - Proficient Bronze Medallion
- Silver Medallion IRB Driver
 - Proficient Bronze Medallion
 - Proficient IRB Crew
 - Hold a current state/territory boat license (where applicable)
- RWC Operator
 - Proficient Bronze Medallion
 - Hold a current state/territory boat/PWC license (where applicable)
 - Additional state/territory pre-requisites as required.

IRB Crew (IRBC)

Demonstrate effective and safe crewing practice and ability including:

- Parallel running
- Figures of eight
- Response to signals
- Negotiation of surf as required
- Demonstrate victim rescue
- Demonstrate ability to carry out a victim lift, exit, carry and lay
- Awareness of Powercraft Code of Conduct.

Silver Medallion IRB Driver (SMIRBD)

Demonstrate the ability to apply safe driving practice including but not limited to:

- Parallel running
- Figures of eight
- Response to signals
- Negotiation of surf as required
- Demonstrate ability to conduct a victim rescue
- Demonstrate ability to carry out a victim lift, exit, carry and lay
- Awareness of Powercraft Code of Conduct.

Rescue Watercraft Operator (RWCO)

Demonstrate the ability to apply safe driving practice including but not limited to:

- Continued application of the SLSA Powercraft Code of Conduct
- Competence in safe RWC Operator techniques including:
 - Ability to carry out an assisted launch from the beach
 - Parallel running
 - Figures of eight
 - Response to signals
 - Negotiation of surf as required
 - Demonstrate ability to conduct a victim rescue
 - Demonstrate the ability to reboard the craft from deep water
- Competence in pre- and post-operation procedures

Specialist powercraft awards (JRB/ORB/RIB Crew, Driver, Skipper)

Skills maintenance for specialist groups shall be determined by the individual group and as approved by your relevant SLS state/territory centre. Skills maintenance may be assessed during normal operational activities.

Side-by-Side Vehicle (SSV)

It is not a national requirement to undertake an annual SSV (ATV) proficiency. Instead, a member's driving license must be checked each year for currency. Each SLS state/territory centre can manage this process and this information can be recorded in SurfGuard.

A member who loses their driver's license (whether through cancellation or suspension) must not be driving the SSV. Provisional drivers are to display plates as required by their state legislative body.

Members must participate in an SSV Operator Induction for each new SSV make and model that they have not driven before. The SLSA SSV Operator Induction Guide is available in the SLS Members Area Document Library.

Age Managers and Age Manager Assistants

Age Manager awards expire after 5 years and must be renewed on expiry to manage Nipper activities on the beach. Age Managers need to refer to the Members Area for the expiry date.

Age Managers and Age Manager Assistants will need to undertake an annual update to keep abreast of changes that may have occurred during the season, with each state rules differing slightly. Please refer to your local state/territory.

A member is proficient:

- If they hold a current Age Managers course (completed online)
- If they hold the current working with children check or equivalent requirement for their state/territory (where applicable dependent on age)
- If they have watched the video released this season by the National Development Chair relating to the changes which have occurred within their area. If a member is unable to complete this component online, they should speak with their Junior Activities Coordinator.

Child Safe

With over 28,000 junior members and 30% of patrolling members under the age of 18, child safety is critically important in Surf Life Saving NSW.

This season all patrolling members over the age of 18 will be encouraged to complete the online SLS Child Safe Awareness course, strengthening our commitment to keeping children and young people safe. This will become a requirement in the 2025/26 season.

The following child safe resources will also be introduced this season:

- A **Club Child Safe Risk Management Document** to support clubs to implement child safe risk management practices in line with the NSW Child Safe Standards.
- A Child Safe Activity Planning Guide to support clubs with child safe risk management when planning for activities involving children and young people, including social activities, carnivals, travel, tours, camps and overnight stays.

These resources will be available on the <u>SLSNSW Child Safe page</u> prior to season start.

Club Management



Key Changes

- The Play by the Rules Member Protection Information Officer (MPIO) Course no longer has an expiry date. As such, members taking on the MPIO position are only required to undertake this course once. Ongoing engagement and upskilling will be provided by SLSNSW through the Member Protection Toolkit, the MPIO networking group, and through webinars outlined within the Executive Training Calendar.
- SLSNSW is adding new workshops to its Club Executive Calendar this year including sessions on insurance, compliance, privacy and data management. We recommend that all new club and branch officers attend the Club Management Induction in August and that all new and existing club and branch officers attend the Governance and Club Management session in October.
- The Surf Life Saving Foundation (SLSF) runs one of Australia's largest 'House and Land' lotteries, offering six luxury prize home draws annually. SLSF is providing clubs with the option of having a customisable web landing page linked to their website for fundraising via lottery ticket sales, with clubs receiving 50% of ticket purchase value.
- New functionality in SurfGuard advises clubs of non-proficient members. Clubs can enable email reminders to be sent out weekly advising of any members who have been allocated a position on a patrol that they are not proficient for.
- A 12-month access limit to Surfguard has been implemented for all users. Branches will provide clubs with a list of current users in August, and clubs will be required to indicate which members still require access. Users not verified as active by a club will be deactivated at the commencement of the season.
- Affiliation forms will be distributed through a DocuSign process this year. It is important that your club officer signs the form via. DocuSign prior to the compliance deadline of 12 September 2024. Upon signing the document, it will be automatically forwarded to the branch officer, requiring no additional action from the club.

- This season the scope of the Member Assistance Program or MAP (formerly known as the Employee Assistance Program or EAP) has been broadened to offer four (4) free confidential counselling sessions to members for Surf Life Saving related concerns (e.g. critical incidents, grievances) without a referral. The MAP is a short-term solution-focused service model.
- Members can now renew their Working with Children Check (WWCC) online through the NSW Digital ID program, which utilises photo verification technology and a liveness check to confirm a person's presence in front of a mobile phone. It's important to note that this method is only for renewals and not for new WWCC applications.
- This season SLSA is introducing three new sub-membership categories including Silver Salties, Nipper Parent and Inclusive Program Participant. The SLSNSW Regulations will be updated once implemented. Further information about these sub-categories will be shared by SLSA to clarify how clubs may like to implement at a local level.
- An online Sexual Harassment and Misconduct Awareness training module has been added to the SLS eLearning platform and is included in skills maintenance for all active members. Club and branch executive members are also strongly encouraged to complete this training.

Lifesaving



Key Changes

- This season, SLSNSW will be rolling out new flexible patrolling standards (discussed at the SLSNSW Lifesaving Conference in late July) to better utilise volunteer time and resources. Further information will be communicated to all clubs on Monday 26th August 2024 regarding these new and updated standards.
- Patrolling members over the age of 18 are encouraged to complete the online Child Safe Awareness course. This will become a mandatory requirement in the 2025/26 season.
- A new Peer Support Program will be implemented this season, providing a proactive and preventative approach to support member wellbeing. Club Peer Supporters will be trained to support individuals who may be experiencing challenges, and to encourage and facilitate early helpseeking behaviours. Branch Peer Support Officers will be trained to attend critical incidents across the branch and provide support to Duty Officers with scene management. They will also be trained to deliver the wellbeing session following the lifesaving-led operational debrief.

Reminders

- All vehicles used by clubs (SSVs, tractors, 4x4s) must have the appropriate registration (which may be conditional). Where Conditional Registration applies, it is highly recommended that the registered area of operation be as broad as possible and that it realistically reflects potential locations of vehicle operations, including during incident responses (e.g. all areas in proximity of the Surf Life Saving Club, adjacent parks, cycle ways, neighbouring surf clubs and beaches, etc.). The intent of this is to ensure that the vehicle is registered to be driven through car parks, pathways, storage sheds and other areas within the vicinity of the club, or when attending to incidents away from the 'own' club and beach (e.g. adjoining park areas).
- Incident reporting is available via the SLS Operations app to be used in place of the paper log. The app will display existing incidents

- and allow for new incidents to be created. Please contact the State Operations Centre with all member injuries.
- Gear and equipment inspections can be managed via the SLS
 Operations app. The app integrates with SurfGuard and helps to reduce the administrative burden associated with gear and equipment inspections. Branch Inspectors need to be registered on SurfGuard to access the app. Please inform Hamish Jones (hjones@surflifesaving.com.au) of your inspectors so that access can be provided.
- The Rescue of the Month award aims to recognise excellence in lifesaving and service delivery, measured against industry best practice and operating procedures. Clubs are reminded and encouraged to nominate their members for this award.
- SLSNSW has confirmed with NSW Maritime that physical Powercraft Licences are no longer required to be carried/held by members who operate SLSNSW powercraft for lifesaving purposes. If members are requested to provide evidence of their qualifications to operate SLSNSW powercraft, they will be requested to provide a copy of their certification within 48 hours. This certification can be requested by emailing education@surflifesaving.com.au.

Education



Key Changes

The opportunity to discuss the below key changes in more detail will be available to all Trainers, Assessors, Facilitators (TAFs) and Chief Training Officers (CTOs) at the upcoming branch pre-season meetings. They will also be presented in the online pre-season module which will be released in August. Completion of the online module is a requirement for annual TAF re-endorsement.

Key changes to be communicated include:

- The SLSNSW Education Standard Operating Procedures (SOPs) have been updated.
- SLSA has refreshed the learning and assessment resources for the IRB Crew and Silver Medallion IRB Driver courses. IRB TAFs have been contacted regarding the changes and how they can upskill to deliver the new course.
- Updates have been made to the Bronze Medallion Assessment Portfolio to streamline the administrative requirements for Assessors. The updated version can be found in the SLS Members Area (SLSNSW folder).
- Following a pilot last season, new features in the Assessing App will be available this season, extending its use to accredited training. Information sessions will be held throughout August and September for clubs wishing to learn more and give it go.
- SLSNSW is introducing a centralised RPL service to support new, returning and existing members with in-depth proficiency and RPL pathways. It is intended that this will support clubs and branches by taking the guesswork out of what is and isn't required when members bring existing knowledge, skills and experience to SLS.
- The mentoring process for Probationary TAFs has been streamlined. A co-delivery process is now in place with immediate effect. Links to the revised SOPs, forms and and a a quick-reference guide to co-delivery are now available on the SLSNSW website.

- The award pre-requisites for Rescue Water Craft (RWC) training have been scaled back to the Bronze Medallion/Cert II in line with national minimum requirements.
- SLSNSW has placed the SLSNSW Pre-course Powercraft Workbook online so that manual marking of this is no longer required. The assessment module can be found in the SLSNSW - Powercraft folder on SLSA's eLearning Platform alongside the new eLearning modules.
- Changes to skills maintenance this season include:
 - Sexual Harassment and Misconduct Awareness training module for all active members
 - A focus on board rescues, carries and drags for SRC and Bronze Medallion
 - A branching scenario for SMPC
 - Surf Risk Rating (SRR) online training and short practical component for SMBM (unless already completed)

U/14 members are still required to obtain their SRC for championship events as per the Surf Sports Manual. The requirement to complete the competition skills assessment remains for all age groups. Refer to the SLSNSW Junior Activity Information Bulletin for more information. There are no other changes to SLSA Award or patrol requirements for any other competitors.

Key Changes

- To support clubs with recruitment and retention activities, SLSNSW is coordinating member-led social media recruitment videos. These videos will supplement existing resources including the Recruitment Toolkit which includes Canva Recruitment Guides where clubs can create personalised recruitment collateral. Branches will also be provided with recruitment collateral in August 2024 to support club and community engagement.
- The SLSA Rewards & Recognition Framework has moved to Manula and is now known as the SLSA Recognition & Appreciation Framework. This framework provides a comprehensive summary of the range of the available recognition awards and how to apply or nominate for them.
- The Active Kids voucher program has moved to a new Service NSW platform. Due to the SLSA IT systems rewrite, vouchers will not be able to be redeemed via the online join and renew processes this season. Clubs have been sent a separate communication outlining their options for supporting families wishing to use an Active Kids voucher this season.
- The SLSA Age Manager
 Course now has an annual skills maintenance requirement which can be completed by watching the SLSA Age Manager Video accessible on the SLS eLearning Platform. It can also be watched as a group at pre-season meetings, and a bulk proficiency processed for attendees. Age managers who have not been active for five years or more will need to complete the full course. The course also no longer requires the third party 'on the beach' assessment paperwork.

The requirement for practical and ongoing mentoring sessions remain, and will be coordinated at a club level.

 Nippers are able to move down any number of age groups, completing the Junior Activities Preliminary Evaluation and program for their desired age group. They can also move up by only one age level, but must meet the requirements for the higher age group. Refer to the Surf Sport Manual – 37th Edition for competition age guides as these have not changed.
